- 2. It was suggested to upload the program detail of IC3A-2013 to the college Web site as well as to inform the NPIU and SPFU to upload the same in their website.

MD and Mr. Radhakrishnan suggested to organize the Conference one day at College premises and another day at Kolkata from next time.

It was suggested to make the relationship with the foreign delegates who will attend the IC3A-2013. It was suggested to organize 2 (two) National and 1 (one) International Conference in every year.

- 3. BOG appreciated the MD & the whole management for their initiative and co-ordination in academic matters.
- 4. MD appreciated to Director for smooth running of the examination system under Autonomous status. DTE asked about the setting of question papers whether it is internal or external. The Director explained the whole system. It was advised to publish the result directly from the Institute from next year onwards and to arrange for tabulation of marks subject-wise and then overall.

Regarding organizing Conference and Workshop the following proposals have been approved:

- (i) As initiated by IT Dept. One International Conference on Computation & Communication Advancement (IC3A-2013) under TEQIP assistance as approved in 22nd meeting of the BOG dated 26.02.2012 is scheduled on 11-12 January, 2013. Budget for the said conference is proposed for about Rs. 10,70,500/-. BOG approved the advance to the extent of like amount made to the Convenor, IC3A-2013 to meet expenditure for the said purpose.
- (ii) Proposal of the EE Dept. for organizing an International Conference on Non-Conventional Energy (ICNCE2014) in February 2014 under TEQIP assistance with tentative budget for the same of Rs. 10.00 lakh.
- (iii)Proposal of the ECE Dept. for organizing a National Seminar on Simulation Approach towards Signal Systems on 31.01.2013 under TEQIP fund with tentative budget for the same of Rs. 32,150/-.
- (iv) Proposal of the ECE Dept. for organizing a 2 (two) days' Workshop on Application of 8051 & PIC Microcontroller on 25-26 February 2013 under TEQIP fund with tentative budget for the same of Rs. 30,000/-.

It was informed that the following 2 (two) proposals for CoEs with budget for each CoE of Rs. 5.00 Cr. has been submitted to NPIU through SPFU. The selection of CoEs will be on competitive basis nationally.

- (i) NANOCERA [Anti-fungal, Anti-staining, High Strength, Nano Ceramic Composite with Environmental Impact] and
- (ii) ACUMEN [Aggregated Cloud Platform for Unified Medicalcare Education and Network-centric utilities using M2M]

BOG approved the initiative of the college for the said CoEs.

☐ Under PG Assistantships 31 first year and 12 second year students (Non-Gate) have been

selected for assistance @ Rs. 8000/- per month w.e.f. 01.12.2012. It was approved by the

members.

☐ It was informed that regarding Research Assistantships for doctoral program the institute

could not proceed further as there were some problems on the part of WBUT regarding

registration of PhD students.

DTE suggested that the identified weak students should be nurtured by their own faculty

members; not necessary to hire the external agencies for their training.

DTE informed that the guidelines for international training of the faculty members would

be issued soon by NPIU; the Chairman would then peruse it and start approval for

sending faculty members abroad on merit basis. He requested the institute to proceed

with such proposals, if any. SPFU will give permission to go abroad for training very

soon.
